Background

The college provides the opportunity to request exemptions based on medical grounds or conscience with the following understandings:

- Unvaccinated students may be subject to such testing protocols as the college may determine necessary for the health of the college community.
- Unvaccinated students may be subject to isolation and quarantine protocols that differ from those applied to those who are vaccinated.
- The college may impose masking and other health-oriented protocols that apply differently to vaccinated and unvaccinated persons.
- The college may limit the ability to participate in certain activities without vaccination based on its best judgment how to protect the health of the community.
- The college cannot exempt students from vaccination requirements that may be imposed by clinical, internship, or other experiential learning sites, and that failure to be vaccinated may affect my ability to complete academic programs.
- The college cannot grant an exemption from NCAA/MIAC regulations regarding vaccination status and testing, masking, quarantine and isolation, travel, and eligibility to practice or compete in athletic contests.
- Any intentional misrepresentation contained in this request or noncompliance with other college policies may result in disciplinary action.
- An administrative fee (\$350 for Spring 2022) will be added to the spring billing for those receiving exemptions based on conscience to cover the costs of monitoring and testing compliance.
